Miscellaneous

Pro rata costs relating to external services decided and appointed by the Members of the General Assembly.

Membership fees are determined by the EU Cloud CoC General Assembly based on a proposal of the EU Cloud CoC Steering Board; Standard fees for services of the EU Cloud CoC Monitoring Body can be determined by the Monitoring Body itself, but must transparently communicated and adopted in consultation with the General Assembly of the EU Cloud CoC.

Full Membership is open to any Cloud Service Provider no matter of size. SME may voluntarily opt-in for this option, in case they want to participate in the further development of the EU Cloud CoC. Non-Voting Membership is open to either Medium or Small Sized Enterprises.

Members of the General Assembly can submit one declaration of adherence per Cloud Service or per Cloud Service family, in case several Services rely on the same technical infrastructure, with regards to hardware and software, and are embedded in the same contractual framework. Within a timeframe of three months, no changes within code related matters are expected, so that the necessary individually assessment and verification of compliance per Service can rely on any prior assessment of the related service family. If services are declared adherent related to a service family that has already been assessed more than three months later than the last assessment of such service family, the declaration of adherence shall require a new assessment.
